Pres's Comments.

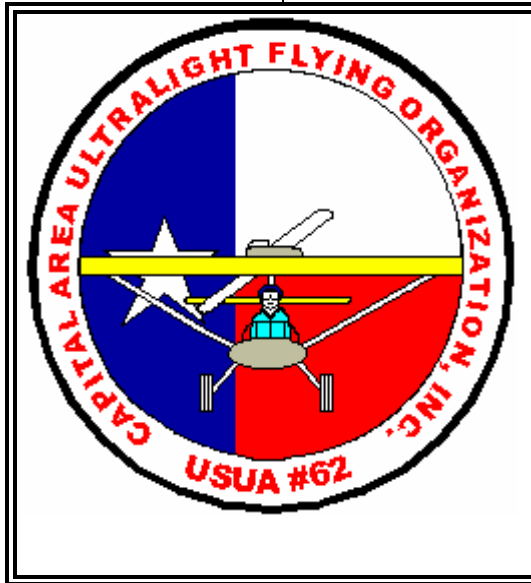
I hope you all are doing well and have a great thanksgiving.
